## **STEELS CREEK AND 'LANDCARE' - Help the Creek Report**

There were around 50 people at the meeting on November 5 to hear Roger Lord of Melbourne Water talk on the Board's "Healthy Rivers" program and the work the Board has done towards the restoration of Steels Creek. This was a most informative evening and the attendance was nearly a record for the Centre, demonstrating the interest local landowners have in the Creek.

Following the talk there were questions to Roger and then we considered whether or not we should form a "Landcare" group to develop a management plan or projects to further help the Creek. Most people wanted to know more about "Landcare" and the various options and implications. A committee including **Ivan Filsell, Andrew Chapman, Stephen Carroll, B&I Day, and Malcolm Calder** was formed to consider the issues and options available and to report back with information and recommendations early in the New Year.

There was general feeling that we shouldn't form a new body in the valley, but that we should look at the advantages of linking anything we finally decide to do into the existing structure of the Steels Creek Community.

## The Friends of Birds and Animals in Steels Creek

Sixty five kilos of seed per week is a lot of bird food! That is only part of what is required to sustain the 120 creatures great and small in the care of Tony Wooley and Georgina Rowley at Babbajin Park, 1 Greenwood Lane: Steels Creek's only animal refuge.

Tony acquired his interest from his British father; growing up in Boronia he lived with exotic birds, finches and other animals sheltered in the back garden. Georgina, Tony and his son Jessie care for about 80 exotic birds and poultry, 20 reptiles, tortoises, ponies, cattle, and one baby wombat named Dozer. While Jessie attends school Dozer sleeps the day away.

The Kangkoa Wildlife Shelter is operated by Fran Henderson and Steve Hunt around the corner on Hargreaves Road. Both groups focus on refuge, rescue and rehabilitation. Fran is a registered veterinarian nurse at the Healesville Sanctuary. A major objective is to return the native animals to their habitat after recovery from injuries or abandonment. Kangkoa offers a home for more than 30 native animals often orphaned through accident or malicious intent.

A few weeks ago, a white station wagon collided with two kangaroos and a wombat. A 'pinkie' or pouch survivor was found and is now in Gee long at a specialist who cares for these demanding orphans. The car will be restored but sadly, the animals are gone forever. Guns, automobiles, feral dogs, cats and foxes (the four legged terrorists of the bush) are the biggest offenders here. Just last week the toll from guns included a goshawk, kookaburra and some ducks. Tony and the team perform more than a dozen rescues and markings per month. Marking is an inspection of a corpse or injured animal to look for a pinkie and evaluate the possibilities. Tony has even used fibre glass to repair cracked tortoise shells.

Flashing his characteristic quick grin, Tony is delighted to report that Steels Creek has 72 species of native birds resident including some local wedge tail eagles with a fledgling, a peregrine falcon and at least one powerful owl. Tony & Georgina and Fran & Steve.

## How Green Is Our Valley?

The Steels Creek Community Centre receives mail from the Port Philip and Western Port Catchment Management Authority, from Melbourne Water and from Landcare Australia, assuming that we are a Landcare group.

In the past we have been involved with the Rabbit Busters Program through a grant received in 2000. Since then we have had a meeting of interested people to discuss the formation of a Landcare group within the Centre, we have had talks from staff of Melbourne Water regarding recent changes to the registration of farm dams, and most recently we had a wonderful talk from Sophie Akers of the Shire on "Living with our Bushland". We all care for our land, but we do not have a focus or status on "Landcare". Many of us have received advice and support for the development and management of our land and there have been some very good results in the overall environment of the valley. But we all do it as individual landholders and, apart from the Rabbit Busters work, there is little attempt to coordinate our efforts across properties which, of course, is the philosophy of Landcare.

There is a potential within Landcare for looking at our valley as a whole and working together to make our different livings as well as improving the environment of the valley. Twice in the last two years we have had people suggest that it would be a wonderful idea to have a walking track along Steels Creek as a recreational resource for the community and as an attraction for visitors. Such a track would need careful planning and design, and the real concerns of farmers

along the creek about stock safety, rubbish and loss of privacy would need to be addressed; but wouldn't it be a great feature for the valley?

To make any progress with ideas of Landcare we need to have a group of people willing to pick up the challenge and work with the community to identify appropriate projects. There needs to be a new driving force with energy and a vision. If there is anyone out there ready to seize the opportunity, please contact the Editor of the Jolly Thing. A strong committee has indicated interest; now is the time for leadership and action!

### **STEELS CREEK LANDCARE GROUP**

*Have YOU Joined Up Yet?*

Steels Creek Landcare Group is now a definite reality in our area, and will shortly be prioritising land degradation issues and planning actions to tackle them in the Steels Creek Landcare area which comprises all land effectively within the Steels Creek catchment, but excluding National Park and State Forest lands. The area is a unique mix of land uses including rural (agricultural and rural living), conservation, and urban fringe properties on the northern edge of Yarra Glen.

Landcare is all about tackling land degradation problems for both economic benefit and long-term protection of biodiversity and natural ecosystems. Problems might include weed invasion, rabbits, protection of native flora and fauna and effective waterway care. Landcare encourages landholders to work together to solve land degradation problems in their own areas, often through coordinated action across a number of properties. It therefore makes sense for as many property holders as possible to become involved.

In early March, the Group held a well-attended public meeting in Yarra Glen. Councillor Di Moore and Member for Seymour Ben Hardman were present. The meeting was held to provide information about the benefits of becoming a member of Landcare and to encourage membership, which costs \$20.00 per property annually.

Members receive the Landcare magazine and access to expert information and funding opportunities for protection of land and natural resources. Steels Creek Community Centre is to receive \$800 to support its environmental work. The Member for Seymour, Ben Hardman, said these funds were for administrative support and work promoting local Landcare projects.

### **Weedbuster Week – think globally, act locally!**

This year, Weedbuster Week is on from 8-16 October. Weedbuster Week represents nine days where Australia's attention is focused on weed related issues. In Victoria, Weedbuster activities are actively promoted in the media.

At the recent Steels Creek Landcare meeting, the continuing spread of **Angled Onion/ Onion Weed** was identified as a worthy target for some local weed busting action at this time in our local area. We won't get rid of this prolific invasive weed in one fell swoop, but we can take some action now and over the next couple of weeks to slow it down.

It was decided not to arrange one single weed busting event, but to encourage those who can to have a go at the outbreaks along Steels Creek Road, particularly over the next couple of weeks. The task is quite simple – *simply knock the flowers off!* This will prevent the plants forming new seed and thus removes one method by which it spreads.

If you have access to a line trimmer or brush cutter, and can spend an hour or two (or more!) over the next couple of weeks, have a chat with Rob Fallon about where would be the best spot to target. You may also see Rob and others, often on a Sunday morning around ten am onwards, doing their bit to keep the invaders at bay. ***Can YOU help them?***

### **LANDCARE – STEELS CREEK ROAD PROJECT**

Thank you to all those residents who responded with interest in the above project. Our application to the Envirofund met the 28<sup>th</sup> of April deadline and we now have to wait until about mid July to see if we are successful. The proposal is to remove and poison the stumps of elm suckers on the west side of Steels Creek road mainly between Pinnacle Lane and Old Kinglake Road, and to plant approximately 2000 trees and understorey plants. The new plantings will be concentrated where the elm suckers are removed and where adjoining landholders have expressed interest.

In anticipation of starting work in August we have a meeting planned for Wed 26<sup>th</sup> July 2006 at Steels Creek Community Centre 7.30pm.

When speaking of planting along Steels Creek Road frequently asked questions are:

1. What about the fire danger?
2. What is the council doing?

Included in our expert reference group are John Sutton captain of Yarra Glen Fire Brigade and Simon Denby, Biodiversity Conservation Coordinator Shire of Yarra Ranges who are more than willing to answer the above questions.

The topics the meeting will address are:

Landcare - Steels Creek Road Project proposed STAGE 1.

Yarra Ranges input to Landcare and Fire Protection. Fire protection built into road reserve management.

Fire protection for Steels Creek properties in general. How to get fire protection advice specific to your property.

This meeting is open to all in Steels Creek and is an ideal opportunity for local residents' input on maintaining the beauty of Steels Creek Road and considering fire control and fire prevention issues without the pressure of fire raining down on us from the Kinglake Ridge.

### **STEELS CREEK LANDCARE GROUP**

An interested group of Steels Creek residents attended the recent landcare meeting at the community centre to discuss planned landcare projects along Steels Creek road with the other stakeholders. These were represented by Cr Jeannette McRae and Marty White from the council, John Sutton and his team from the Yarra Glen fire brigade and Tony Fitzgerald

Kinglake Parks Ranger.

Ivan Filsell outlined our proposed weed clearing, sucker removal and replanting plans and our Enviro grant application status which is waiting, waiting, waiting. This was followed by in principle support from the council representatives and a view that council would give some support even without the grant money. John Sutton gave a clear picture of the fire brigade's support for good fire breaks to be included in the plan and general tips on a fire safe approach.

The fire brigade was keen to emphasize that Steels Creek is very much on their fire protection map and any residents requiring specific fire protection advice are most welcome to approach the fire brigade.

Tony Fitzgerald gave a positive report on the State of Kinglake National Park after the recent fires and showed that in spite of much worry at the time, the long term effect of the fires is positive. This was reinforced by the recent Lyrebird survey that showed good numbers even in the burnt areas. Tony was also able to outline future control burn plans including more around Brock Spur and Mt Everard but only, he assures us, if conditions are right.

Now mowing is well advanced, normally I complain that they mow too early before native wildflowers have set seed, but not this year most are well and truly dry. ## **OH DEER WHAT CAN THE MATTER BE?**

Steels Creek Landcare is applying for funding through the Port Phillip and Westernport Catchment Management Authority (PPWCMA) to embark on a three year integrated pest animal management project to investigate management options for the problem of feral and/or native animals damaging tree plantings and crops. This effort is expected to be an inter-agency effort involving local land holders, together with the Shire of Yarra Ranges, Melbourne Water, the Australian Deer Association, the Kinglake National Park and your local Landcare group.

Initial activities are being planned to determine the extent of the problem and to then develop appropriate responses. Activities are expected to include surveys to determine which properties are affected, a joint information and educational session to raise awareness and a demonstration project to trial options. Participants in Melbourne Water's Stream Frontage Management Program and Greening Australia tree planting programs as well as landholders experiencing tree and crop damage are invited to come forward to participate. Expressions of interest about receiving further information or participating in this project are now being sought.

Most of us are not up at three in the morning to see the animals but find broken tree limbs and damaged foliage later in the day. Browser or grazer? Deer or marsupial? How to tell? What to do?

## **Land care: Help replant the Valley**

*Annual General Meeting of Steels Creek Landcare Group will be held on Thursday 6th December 2007 at the Steels Creek Community Centre, 699 Steels Creek Road, Steels Creek, commencing at 7.30 PM.*

During this year, Steels Creek Landcare has been undertaking the Revegetation Program along Steels Creek Road. This has so far resulted in approximately 1000 trees and shrubs being planted during the autumn and winter period, when rainfall was kind (if not particularly abundant). We have a similar planting target still ahead of us. Our intention had been to recommence planting in the spring, but lack of rainfall during that period and concern about lack of rainfall and high temperatures over summer has resulted in deferral of further planting until Autumn 2008. Assistance from many people with planting so far has been greatly appreciated, and the results are now starting to become evident. We look forward to further community plantings in the autumn – winter period next year. If you would like further information, please contact Ivan Filsell.

Steels Creek Landcare has also recently applied for funding to facilitate a new project aimed at demonstrating and evaluating different methods of managing damage to vegetation (including stream-side and other revegetation projects, existing vegetation and also vines) that is being caused by deer, in particular sambar. We expect to hear results of our funding application during December. We are currently developing a questionnaire for circulation in the wider Steels Creek area that will be inviting landholders to register with this project and to

provide further details about the extent and location of damage being experienced. Watch your mail box – we hope to hear from you! The bigger the response we get, the better will be the result. If you would like further information, please contact David Allan.

## **Pest Animals and Birds Survey Update**

Thank you to all those who responded to the survey on Deer, Other Pest Animals and Birds in the Steels Creek area, that was conducted during June.

Responses have now been summarised, and they do confirm what many have already known, that there is damage being caused by deer (generally sambar), rabbits, sulphur crested cockatoos, mynahs and starlings. Mention was made of some 'roo damage, but on the basis of responses received, 'roos have not been identified as a significant problem in general.

As noted on the survey forms, Hoogies have donated a gift voucher that will be presented to one of the respondents to the survey. A draw to determine the winner of the voucher will be conducted at the first Steels Creek Market in August.

It is intended that information about these issues and the experience of other groups in the Yarra Valley and elsewhere will now be accessed, and ideas for management of problems will also be sought. This information will then be shared with those who responded to the survey, and will also be summarised as a Steels Creek community resource document.

### **Weed control**

Responses from our member survey indicated a high level of concern about weeds and weed control. Kirk McDonald, Rural sales manager with Hoogies, kindly gave his time to address this issue. The first step in dealing with weeds is to be able to identify them and this was aided on the night by a table full of fresh picked weeds from the surrounding area that members brought along. These included the common problems of cape weed, sweet pittosporum, bridal creeper and a selection of the many bulb species that were popular garden plants 100years ago and have escaped to be environmental problems now.

Kirk emphasised the need for a planned approach to weed control that provides many methods of attack on the problem. Non-chemical methods of attack include cultural, biological, physical and mechanical methods. These should be adopted as part of an overall plan designed to advantage desirable plants and disadvantage undesirable ones (weeds). Chemical weed control has its place as part of the overall plan but used alone or indiscriminately can cause as many problems as it solves.

A number of important points came out of this meeting that may be useful to our members and others in the area:

1. Kirk MacDonald through Hoogies has a strong back up team for advice on weed control measures and appropriate use of chemicals.
2. Katie Jacobson, Shire of Yarra Ranges landcare coordinator and Kirk can help with short courses on farm planning and chemical handling.
3. Landcare members can attend these courses at a considerable discount.
4. For more information contact Steels Creek Landcare Group or Kirk or Katie direct.

Kirk's talk was informative and well prepared and presented and all who attended left with a new enthusiasm to tackle the weed problems with a new plan. Ivan Filsell, Landcare Coordinator.

Further to the Steels Creek survey of deer and other pest animals and birds, there have been a number of actions happening behind the scenes. Steels Creek Landcare is a member of the Yarra Ranges Landcare Network and several other network member groups have expressed interest in what is happening around Steels Creek. This has resulted in a recent meeting organised by the Shire where interested groups were present along with representatives of several other stakeholder individuals and organisations. The object of the meeting was to better understand concerns and also the range of possible management options that could be of use. The importance of taking a well planned approach to any management action was emphasised by all.

Next steps are likely to be - identifying specific areas where actions could best be undertaken, planning what action would appear most appropriate in those areas and how it could best be undertaken. It is also likely that a guide to possible resources and management techniques will be compiled that could be made available to affected land holders.
